

SERVICE CHARGE EXTENSION PETITION

Petition

WHEREAS, by a document recorded in the Real Property Records of Harris County Texas in Volume 5205 at Page 384 on July 30, 1963, Friendswood Development Company imposed an annual Community Services Charge, hereinafter referred to as a regular assessment, to be paid by all owners of real property in Clear Lake City for the purpose of creating a fund to be used for the common good of the community, civic betterment, educational and public recreational purposes;

WHEREAS, the assessment created in the document expires by the terms of that document on July 30, 2003;

WHEREAS, the 1997 Regular Session of the 75th Legislature amended the Texas Property Code by adding Chapter 206 which authorizes Clear Lake City Community Association to approve the extension of the service charge assessment and to submit the extension of the restriction document provisions imposing the assessment to a vote of the owners in the subdivision;

WHEREAS, on the 3rd day of March, 1998, the Board of Trustees of the Clear Lake City Community Association approved a proposal extending the restrictions created in the above described document and making the duration of the restrictions imposing the assessment perpetual unless discontinued by a vote of the owners in Clear Lake City as described in said document;

WHEREAS, on the 3rd day of March, 1998, the Board of Trustees of the Clear Lake City Community Association authorized submission of the proposal for such an extension to a vote by the holders of record title (whose names appear on the deed to the property) of real property in Clear Lake City; and

WHEREAS, no other terms of the July 30, 1963 document will be amended by this vote;

NOW THEREFORE, the Clear Lake City Community Association hereby submits such extension of the restriction imposing the regular assessment to a vote of the owner(s) of real property located within Clear Lake City who may cast their votes on ballots in the form of the ballot attached hereto as Exhibits A and B.
